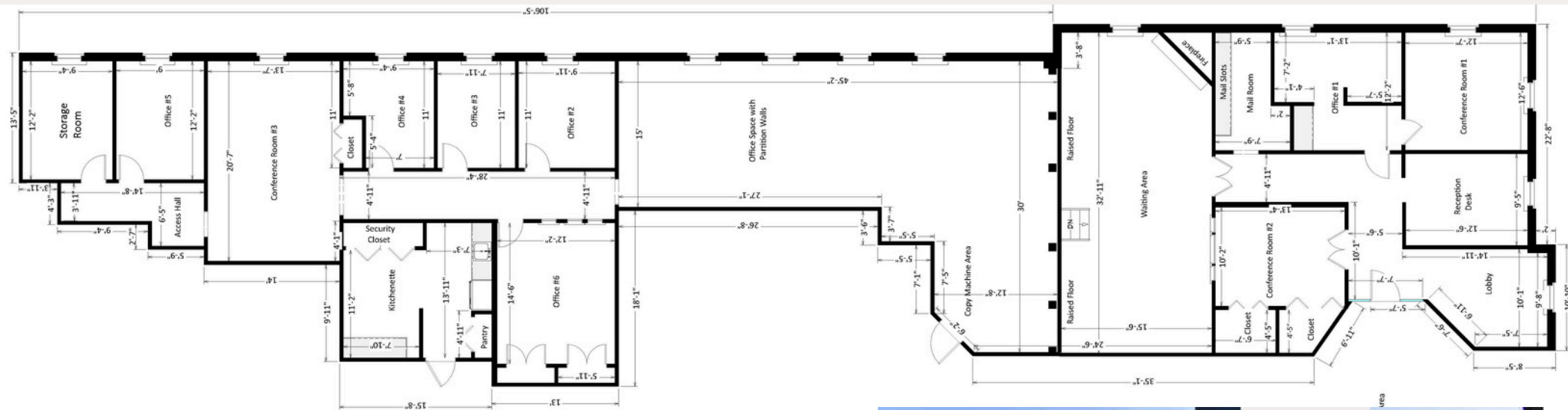

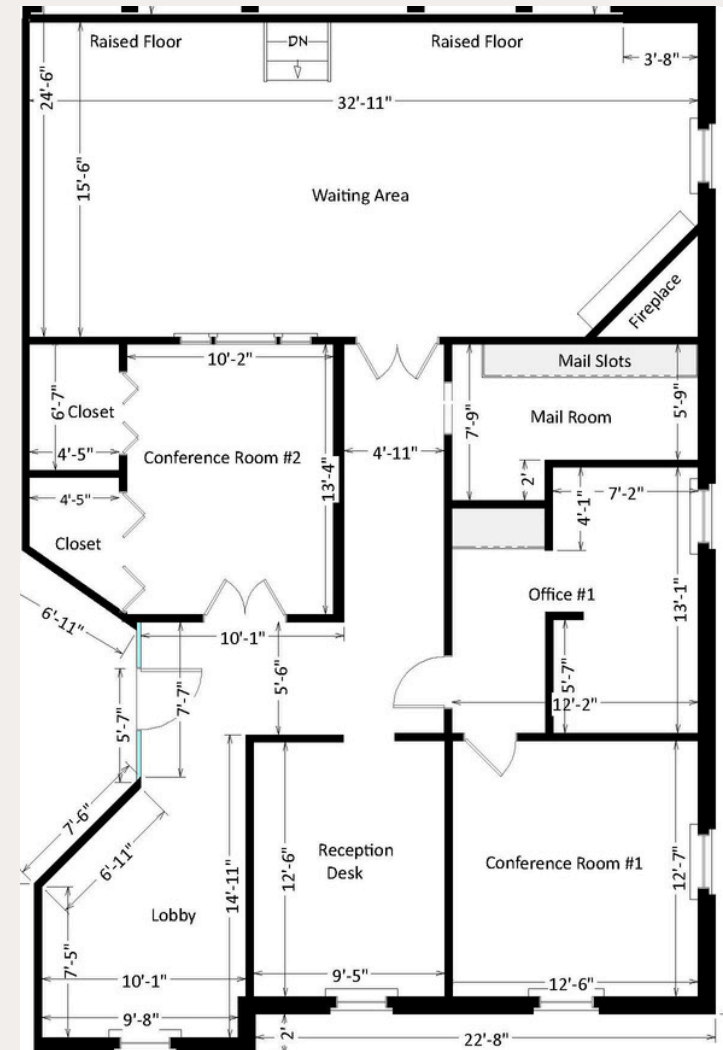

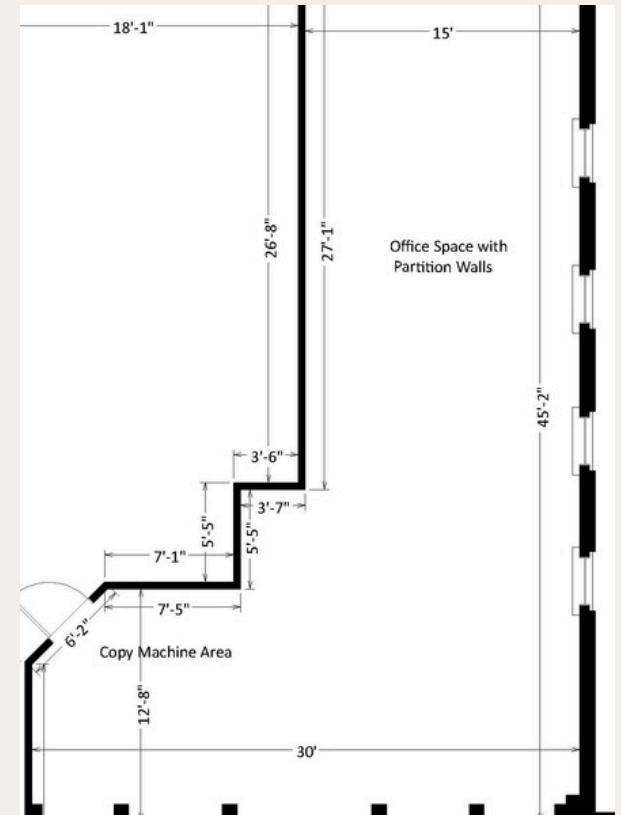

## FLOORPLAN OPEN WORK SPACE



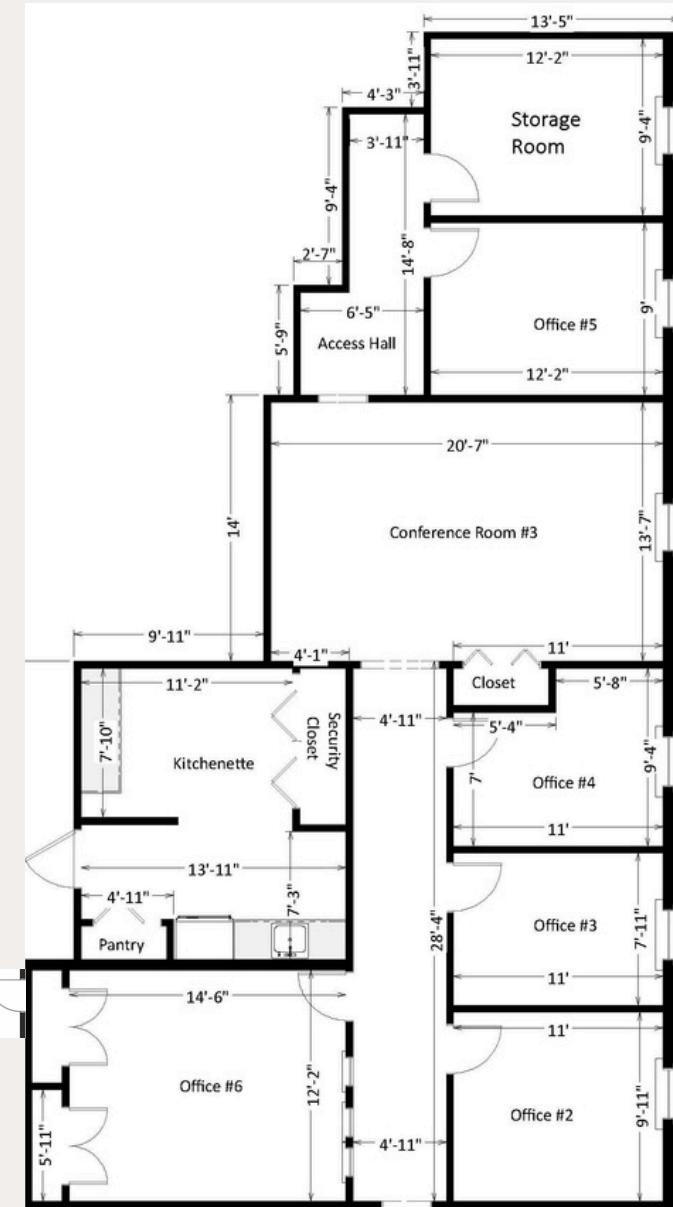

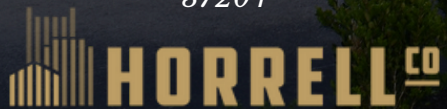
